Eurasian Milfoil

In 2012, the findings of a study we commissioned regarding the milfoil issue in our lake indicated that about 2% of Lac Bernard was covered with Eurasian Milfoil. In 2015, the Association commissioned a second study indicating that 15% or 525,000 square meters of milfoil covered the lake. We are undertaking a study this year to evaluate to what degree the problem has spread and how much of the lake is now covered by Eurasian Milfoil.

Why is Eurasian Milfoil a Problem for our lake?

First and foremost, it takes over the ecology of the lake blocking out light and crowding out aquatic life required for a healthy fishery. In short, the ecology of the lake and the biodiversity are declining as this invasive weed continues to spread. As a result, it reduces the ability for everyone to enjoy swimming, boating and other water sports. In time, it will hurt the real estate values of our properties.

What is the Association doing?

To start, we have commissioned an environmental consultant to conduct a new study (July 2021) of the milfoil problem. Thankfully, we have sought and received 50% funding for this study from the Municipality of La Pêche.

Our consultant (ABV des 7) has recommended that yellow buoys be put out again this year to reduce boat traffic in heavily infested areas in order to slow down the spread of milfoil. ABV des 7 will be doing the research at our lake in early July and this study will form the basis to our submission to the Québec government to make application for a permit to lay burlap in heavily infested areas of the lake. We chose burlap over other alternatives such as harvesting, vacuum suction, chemical alternatives and using weevils since burlap is the only approved method eligible for a permit (and funding).

The application for permit will be submitted by the fall with expected approval for our plan by early 2022. Once the permit is approved, we will be submitting our plan to the Quebec, federal and municipal governments and seeking financial assistance to aid in the costs for the roll out. Once funding is approved, we expect to roll out the initiative by spring of 2022. The roll out plan is designed to cover the highest density milfoil areas of the lake within five years.

Once we have covered the high density, heavy boat traffic areas with burlap, we will be in a position to remove and decommission the yellow buoys.
